



MOP(S) ACT EMPLOYEES

ADDITIONAL ANNUAL LEAVE CREDIT

- The *Commonwealth Members of Parliament Staff Enterprise Agreement 2016–2019* ('Enterprise Agreement'), provides for additional annual leave accruals at the rate of one day for every two Sundays and/or public holidays spent traveling to Canberra for Parliamentary sittings on the following day at the direction of the employing Office Holder, Senator or Member.
- Employees whose work base is Western Australia, the Northern Territory or the Federal electorates of Capricornia, Dawson, Kennedy, Herbert or Leichhardt, and other locations as approved by the Special Minister of State, may accrue additional annual leave in accordance with the Enterprise Agreement.
- A maximum of eight days additional annual leave per calendar year may be claimed.
- Claims for Excess (Canberra) Travel Leave must be received by the Department within six months after the travel has been completed or the additional annual leave will not be provided.
