

Members of Parliament (Staff) Act 1984

**MINISTERIAL STAFF – PRIVATE INTERESTS DECLARATION,
CODE OF CONDUCT AND SECURITY CLEARANCE**

I, DON FARRELL, Special Minister of State, for and on behalf of the Prime Minister determine under subsection 14(3) of the *Members of Parliament (Staff) Act 1984* (the Act) that:

1. Determination 2018/27, made on 27 November 2018, is revoked.
2. The following terms and conditions apply to the employment of the staff of Ministers employed under Part III of the Act:
 - (a) The employee must provide to the employing Minister, and keep up-to-date, a private interests declaration.
 - (b) The employee must comply with the Ministerial Staff Code of Conduct.
 - (c) Employment is conditional on the employee obtaining and maintaining a security clearance at Negative Vetting Level 2 or at a level approved subject to clause 2(d).
 - (d) In exceptional circumstances the Secretary of the Attorney-General's Department may, on the recommendation of the Minister's Chief of Staff and Portfolio Department, approve a variation of the level of security clearance required under clause 2(c) of this determination where:
 - (i) in the case of an electorate officer who works to a Minister who is a member of the National Security Committee of Cabinet, the electorate officer has no access to security classified information above Protected; or
 - (ii) in the case of an electorate officer who works to a Minister who is not a member of the National Security Committee of Cabinet, the electorate officer has no access to security classified information above Secret.
