Agenda Item 1 – Welcome and apologies

- The chair opened the meeting with an acknowledgement of country.
- The chair reminded all parties of their good faith bargaining requirements.
- Chair advised that the department is available out of session to discuss any concerns with the behaviour of representatives.

Agenda Item 2 – Action item update

Agenda Item 3 – Initial remuneration discussion

- The chair confirmed the Commonwealth's pay offer is the maximum increase available under the *Australian Government Public Sector Workplace Relations Policy* 2023 (the policy) for all APS and non-APS agencies, which is an 11.2% increase over the lifetime of the agreement. This was proposed as a 4% increase on commencement of the agreement, 3.8% increase in year 2 of the agreement, and 3.4% in the final year of the agreement and is applicable to base salaries and remuneration-based allowances.
- The chair outlined funding parameters which included adjustments to other allowances including ESA and PSA.
- Bargaining representatives spoke to their claims for general pay increase.

Agenda Item 4 – Discussion of Electorate Officer remuneration and claims relation to mapping to APS classifications

- The group discussed employee representative claims seeking significant increases to electorate employee base salaries. Employee representatives supported their claims with a business case based on work value standards and highlighted significant work that had been undertaken to map the responsibilities of various electorate officer classifications to APS work level standards.
- There was discussion about the benchmarking of MOP(S) Act employee classifications against the APS, and other industries.
- The chair advised that changes to classification structures that include an increase to costs would require an exemption from the policy, however Finance would seek to have further discussions with the Australian Public Service Commission (APSC) in relating to mechanisms in accordance with the policy.

Agenda Item 5 – Other Business

- Finance agreed to send a note confirming that representatives had selected "option 1" on timings for further meetings. This includes two full-day meetings on Tuesday 30, and Wednesday 1 May, followed by 3-hour meeting on Friday 3 May commencing at 12pm.
- The chair advised that this will be confirmed in writing to representatives.

Agenda Item 6 - Next meeting - APH – Friday, 5 April 2024
