Agenda Item 1 - Welcome and apologies

Agenda Item 2 – Action item update

• Finance discussed protocols with bargaining representatives regarding the department's communication with all MOP(S) Act employees. As a courtesy, Finance agreed to advise representatives before we send out all staff communications in relation to enterprise bargaining.

Agenda Item 3 - Remuneration

- The chair responded to claims on remuneration by confirming the government's pay offer of 11.2% over three years. The chair confirmed that any backdating would be subject to meeting the timelines outlined in the *Public Sector Workplace Relations Policy 2023 (the policy)*.
- Employee representatives sought clarification on which minister(s) is responsible for the administration of the policy.
- The chair agreed to recirculate the policy, as well as map the APS common conditions to MOPS conditions.

Agenda Item 4 - Allowances

- Bargaining representatives spoke to their claims for the introduction of some new allowances and how current arrangements impact MOP(S) Act employees.
- Finance agreed to discuss the application of the policy to the creation of new allowances with the APSC.
- The chair highlighted wanting future discussions on how casuals are engaged to create administrative efficiencies without reducing employee entitlements.
