# MoPS EA Bargaining Meeting 9 – Record of Meeting

#### Agenda Item 1 - Welcome and apologies

• The chair opened the meeting with an acknowledgement of country and sought feedback on the agenda that had been previously circulated to bargaining representatives. There was a consensus to discuss the Commonwealth's proposals and responses to claims received to date.

#### Agenda Item 2 - Action item update

• There was no update on Action items arising from previous meetings.

#### Agenda Item 3 – The Commonwealth's proposals and responses to claims

- The chair provided bargaining representatives with an overview of the Commonwealth's proposals and
  responses to some of the claims received to date. The chair noted that a response document would be
  circulated to representatives after the meeting which would provide detailed responses to individual claims
  and further information on the Commonwealth's proposals.
- Bargaining representatives expressed concerns regarding proposed new allowances indicating the proposal
  may not sufficiently address claims raised relating to salaries and allowances not adequately compensating
  employees for the unique work of electorate employees.
- The chair acknowledged the disappointment of bargaining representatives, and explained the bargaining policy does not provide for remuneration increases above the 11.2% over three years.
- The chair proposed to provide bargaining representatives time to review and consider the tabled responses and proposals, and provide comment and questions at subsequent meetings, or directly via email for response and circulation to the bargaining group.

### Agenda Item 4 – Discussion on future Bargaining meetings

- Bargaining representatives agreed that additional meetings would be scheduled to further discuss the Commonwealth's proposals and responses.
- The chair discussed a proposed timeline with additional meetings and key dates for finalising a proposed
  Enterprise Agreement, and agreed to distribute this to representatives for their consideration and feedback
  given there were differing views from the group regarding how to best balance EA bargaining meetings,
  sitting periods, and the availability of individual bargaining representatives.
- The chair put forward a proposal to split the next three full day meetings into sections, corresponding to the Enterprise Agreement for discussion, to provide flexibility for representatives to prioritise time and attend meetings that align with their areas of focus.
- If any bargaining representative is unable to attend a particular meeting, Finance is happy to receive any feedback via email and can circulate that feedback to other representatives along with the record of the meeting to ensure visibility. If these mechanisms for comment are not suitable, we can work with individual representatives as needed.
