MoPS EA Bargaining Meeting 10 - Record of Meeting

Agenda Item 1 – Welcome and apologies

- The chair opened the meeting with an acknowledgement of country.
- The chair noted there were several representatives that were unable to attend due to sitting and Budget Estimates and clarified that the meeting was for representatives to provide feedback and ask questions relating to the Commonwealth's proposal and response to claims and to not share any new information or make any decisions.

Agenda Item 2 – Feedback on Commonwealth's proposals and responses to claims

- Bargaining representatives engaged in a productive discussion regarding the Commonwealth's
 proposal and response to claims. Representatives had the opportunity to raise concerns and provide
 initial feedback.
- Bargaining representatives expressed frustration with the Commonwealth's limitations to address base salary claims above 11.2%.
- Bargaining representatives talked through their concerns regarding the proposed new allowances and their potential impacts.
- Consensus was reached that Finance would investigate if further adjustments would be possible under the policy.
- CPSU representatives again highlighted concerns staff have raised when required to undertake same-day travel.
- Representatives discussed employee classification titles and how they no longer reflect the work
 that is being done in specific roles. The chair clarified that local titles could continue to be used by
 individuals.
- Bargaining representatives shared strong views on their understanding of the purpose of ESA and PSA including in relation to public holidays and 'on call'.
- Representatives expressed concern that their feedback in relation to the pay offer for electorate
 office staff and aspects of the proposed allowances were not understood by the Department. The
 chair explained that the Commonwealth's proposals and responses to claims are required to be
 assessed against a number of factors, including policy parameters. Representatives were
 encouraged to put concerns in writing if they felt they had been unheard in the meeting or there
 was confusion.

Agenda Item 3 - Next meeting - APH - Wednesday, 12 June 2024

- Finance confirmed its intention to share a draft EA ahead of the next meetings.
- The chair suggested splitting the next three meetings on 12, 13 and 14 June 2024 into sections corresponding to the Enterprise Agreement enabling representatives to prioritise attendance based on areas of focus.
- Representatives were urged to provide feedback on the times scheduled for future meetings.
